The short-listed tenderers will then be interviewed by a panel. The facilities of those successful at the interview will then be inspected. This exercise will be the basis for consideration of an award.

No employee of the School Nutrition Programme or their close relative would be considered for the award of contract.

Tenders must be accompanied by valid income Tax and Value Added Tax Clearance Certificates.

Tenders in duplicate must be enclosed in a sealed envelope and deposited in the Brown Tenders Box located in the lobby of the Board's Office no later than 1.00 p.m. on Thursday 18th October, 2001. The envelope must be addressed to the Director of Contracts and must be marked on the outside: "Tender for the provision of Meals under the School Nutrition Programme 2002–2003—Ministry of Education".

Tenders will be opened publicly shortly thereafter. The tenderer or his representative may be present at the opening.
