THE TRINIDAD AND TOBAGO RACING AUTHORITY wishes to advise of the following corrections/omissions to the Schedule of Amendments to the Rules of Racing 1991, as approved by the Authority at a meeting held on Thursday 8th June, 2000.

#### Rule 2—Interpretation

“Starter”—to be rescinded and replaced with amendment as published in *Gazette* on 6th June, 2000.

#### Rule 7—Powers of the Trinidad and Tobago Racing Authority

Subsection (f) is rescinded and replaced as subsections (4)(f) and (g) as amended, and published in *Gazette* on 6th June, 2000.

#### Rule 23—Regulations for Race Meetings, Programmes

Include new subsection (1) to read:

“These Rules shall supersede the conditions of any race or the regulations of any race meeting should they be in conflict”.  
Present subsections (1–9) to be renumbered (2–10).

#### Rule 33—Disqualification of Horses

Delete subsection (1) as amended and published in the *Gazette* on 6th June, 2000.
