### APPOINTMENT OF A TRANSIT SHED (Customs Act, Chap. 78:01)

IN ACCORDANCE with the requirements of section 2 of the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, do hereby give notice of the appointment of the place described in the Schedule hereunder as a Transit Shed for the storage, pending entry for home consumption or export, of the following goods, as shall be deposited by or in the Transit Shed of Messrs. Amerijet International Inc.—situate at Piarco Airport—Storage of machinery, equipment, raw materials, semi-manufactured goods and other goods imported as cargo and such other goods as I may subsequently approve.

#### SCHEDULE

The building to house the Amerijet International Inc., Transit Shed, situate at Piarco International Airport, in the Ward of Tacarigua. The area measures 48.75 metres at the eastern and western sides and 22.14 metres at the northern and southern sides, comprising a total surface area of 1079.32 square metres.

The walls of the building are constructed of concrete blocks with a roof of steel frame covered with galvanized sheets. Access doors are made of steel. The building is rectangular in shape with a parcel of land which is bounded on the west by the Airport Authority of Trinidad and Tobago Public Car Park, on the north by Ramp Area of the Piarco International Airport, on the east by lands owned by the Airport Authority of Trinidad and Tobago and on the south by a building owned by JSL Speedpax Complex.
