## TRINIDAD AND TOBAGO RACING AUTHORITY

### AMENDMENTS TO RULES OF RACING 2000

THE TRINIDAD AND TOBAGO RACING AUTHORITY gives notice of the following amendments to the Rules of Racing 2000 (amended to date).

#### *Rule 2—Interpretation*

Rule 2 is amended by including the undermentioned in sequence after “Official Veterinarian” and appearing before “Owner”.

“Optional Claiming Race” means a contest restricted to horses entered to be claimed for a stated claiming price, and to those which have started previously for that claiming price or less, but have not been entered to be claimed.

#### *Rule 23—Regulations for Race Meetings, Programmes*

In subsection (3) after “claiming”, include in descending sequence “Optional claiming”.

The final line of this subsection is also amended to include after “Claiming”, the words “and Optional Claiming”.

Subsection (6) is amended to include a second paragraph after the word “Official” in the third line.

“No Cup/Trophy can be assigned to a race unless the provisions of Rule 23(5) are met. Gifts of the sponsors will be permitted to the owner, trainer, jockey and groom in any race provided that—

Such must be published in the Official Race Programme.

The value of these gifts must not exceed five hundred dollars (\$500.00); except for sponsor’s products and other than those with monetary considerations.

The above amendments to the Rules of Racing were approved at a meeting of the Trinidad and Tobago Racing Authority held on Thursday 17th August, 2000.
