TRINIDAD AND TOBAGO RACING AUTHORITY

AMENDMENTS TO THE RULES OF RACING 2000

THE TRINIDAD AND TOBAGO RACING AUTHORITY gives notice of the following amendments to the Trinidad and Tobago Racing Authority Rules of Racing 2000:

Rule 100—

MEDICATION AND PROHIBITED SUBSTANCES

R. Penalty recommendations (in the absence of mitigating circumstances).

Subsection B(1)–(5) inclusive is rescinded and replaced with the following:

- (1) *Class 1*—One to five years suspension and a fine not exceeding \$500.00 and loss of purse.
- (2) *Class 2*—Six months to three years suspension and a fine not exceeding \$500.00 and loss of purse.
- (3) *Class 3*—Three months to two years suspension and a fine not exceeding \$500.00 and loss of purse.
- (4) *Class 4*—One month to one year suspension and a fine not exceeding \$500.00 and loss of purse.
- (5) *Class 5*—Zero to six months suspension with a possible loss of purse and/or fine not exceeding \$500.00.

The above Amendments to the Rules of Racing were approved at a meeting of the Trinidad and Tobago Racing Authority held on Thursday 12th October, 2000.
