VACANCY IN THE JUDICIAL AND LEGAL SERVICE

MAGISTRATE, JUDICIARY (MAGISTRACY)

Minimum Requirements as provided in the Summary Court (Amendment) (No. 2) Act, 1997

No person shall be appointed a Magistrate unless he has been admitted to practise as an Attorney-at-law in Trinidad and Tobago and has practised as such for a period of not less than five years save that for the purpose of satisfying the latter requirement practice as an Attorney-at-law or as a Barrister or Solicitor and service as a Judicial or Legal Officer in the Commonwealth country, shall be deemed to be practice as an attorney-at-law in Trinidad and Tobago.

Kind of Work

Sits as Judge in the Petty, Civil and Magistrates' Courts, hearing of evidence and making determinations in accordance with the laws of the country; performing quasi-judicial functions such as sitting as Coroner at inquests and acting as Chairman of Licensing Committees.

Group IV: \$7,590–\$8,400 per month (1993).
