CONSULTANCY SERVICES FOR THE DELIVERY OF SPECIALIST COURSES FOR NGOs AND CBOs UNDER THE COMMUNITY DEVELOPMENT FUND

IN ACCORDANCE with Loan Contract 872 OC-TT between the Inter-American Development Bank and the Republic of Trinidad and Tobago and as part of the Institutional Strengthening Programme for NGOs and CBOs, proposals are invited from consulting firms to provide training in the following courses:

1. Training of Trainers for the NGO sector.
2. Project Cycle Management for NGOs and CBOs.

These Courses must be certified by an accredited academic institution with recognised certificates presented to successful participants on completion of the course(s).
