APPOINTMENT OF A TRANSIT SHED (Customs Act, Chap. 78:01)

In accordance with the requirements of section 2 of the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, do hereby give notice of the appointment of the place described in the Schedule hereunder as a Transit Shed for the storage of general cargo which shall be subject to such regulations as may be made under the Customs Act, Chap. 78:01, pending entry for home consumption or export, as shall be deposited by or in the Transit Shed of Messrs. General Aviation Services Limited.

The premises to house the Courier Facilitation Centre, situate at Piarco International Airport, in the Ward of Tacarigua, on the ground floor of a commercial building owned by JSL Speedpax Complex and located on northern and eastern sides of an L-shaped area measuring 26.2 metres x 10.98 metres in the east and 20.73 metres x 11.28 metres in the west, comprising a total area of 521.72 m² and constructed essentially by concrete blocks in a steel framework and covered by a roof of galvanized iron sheets.

The building is bound on the north by Amerijet Transit Shed, on the south by the Golden Grove Road, on the east by lands owned by the Airports Authority of Trinidad and Tobago and on the west by a Road Reserve 10.06 metres wide and a Public Car Park owned by Airports Authority of Trinidad and Tobago.
