APPOINTMENT OF A PRIVATE WAREHOUSE
(*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, acting under the provisions of sections 2 and 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private/Customs Area for the storage of machinery, equipment, raw materials, semi-manufactured goods and other ingredients imported or taken out of bound by Interior One Limited, Cyrus Road, El Socorro Road Extension, for the manufacture of Vertical and Horizontal Blinds or other goods as may subsequently be approved.

SCHEDULE
