The Ministry of the Environment was established on 22nd October, 1999. It comprises a staff of nineteen (19) and is headed by the The Honourable Dr. Adesh Nanan, Minister of the Environment.

Our Mission

"The promotion of sustainable development of Trinidad and Tobago by seeking to ensure that environmental concerns are adequately incorporated in all decisions involving the allocation of the country's resources".

The Core Activities of the Ministry of the Environment—

- 1. Development of the policy framework (national and sectoral) for sound environmental management;
- 2. Monitoring and evaluation of the implementation and effectiveness of environmental policy;
- 3. Promotion and facilitation of the harmonisation of social and economic policies with national environmental policy objectives;
- 4. Design and implementation of public awareness and education programmes and projects directed at empowering individuals, corporate citizens (public and private sectors), and members of civil society with the values, attitudes, knowledge base and skills for good environmental stewardship;
- 5. Design and implementation of programmes and projects pursuant to national environmental policy objectives;
- 6. Conduct of research to inform the formulation of environmental policy;
- 7. Promotion and facilitation of Government's efforts to promote sustainable development;
- 8. Act as the Political Focal Point for the Multilateral Environmental Agreements (MEAs) to which the Government of the Republic of Trinidad and Tobago is signatory;
- 9. Provision of ministerial oversight to the Environmental Management Authority; the Trinidad and Tobago Solid Waste Management Company Limited; the Institute of Marine Affairs and the Water Resources Agency; and
- 10. Assist in the identification and mobilisation of financial and technical assistance to support Government's efforts to promote sustainable development.
