APPOINTMENT OF A PRIVATE WAREHOUSE

(Customs Act, Chap. 78:01)

In exercise of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Annabelle Marshall, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs. A. S. Bryden & Sons (Trinidad) Limited, Lapwing Drive, Barataria—Wines, Whisky, Liquer and other spirits, Electrical Appliances, Refrigerating Appliances, Ropes and Cables, Domestic Appliances, Food Preparation, Hardware and other general cargo and such other goods as I may subsequently approve.

SCHEDULE

Two separately enclosed areas situate on the southern side of A. S. Bryden's Warehouse Complex at Lapwing Drive off Bhagowtie Trace Extension via Don Miguel Road, San Juan, the Complex being on the northern side of the Churchill-Roosevelt Highway.

Room No. 1, a warehouse for general cargo measures 22.9 metres by 21.9 metres, a total area of 501.5 square metres is constructed of reinforced concrete perimeter walls with a roofing of aluminium sheets supported by steel beams.

Room No. 2, which would be used for warehousing wines, whisky and other spirits, measures 27.4 metres by 22.9 metres, a total area of 627.46 square metres. The southern and eastern sides are of reinforced concrete and the northern and western sides are of BRC Wire supported by steel frames.

The property is bounded on the north by a vacant lot owned by L. J. Williams, on the south by A. S. Bryden's Administrative Offices and Specialist Chemicals Limited, on the west by vacant lots and on the east by Lapwing Drive, Barataria.
