TENDERS are invited for the repairs of Nine (9) Landslips under the Reinstatement and Stabilization of Failed Slopes Project. Three (3) are on the North Coast Road (Contract No. 12), two (2) on the Moruga Road (Contract No. 13) and four (4) on the Morne St. Catherine Road (Contract No. 15).
