## ADVERTISEMENT FOR POST OF SENIOR MAGISTRATE, ST. VINCENT AND THE GRENADINES

APPLICATIONS are invited from suitably qualified persons for the post of Senior Magistrate, Magistracy Department, St. Vincent and the Grenadines.

### Qualifications

Professional qualifications as a practising Barrister-at-law in Private Practice or in the Public Service, with at least seven (7) years experience.

### Key Responsibilities

The Senior Magistrate is the Vice-President of the Family Court and reports to the Chief Magistrate/President, Family Court.

### Responsibilities include:

To undertake the duties ascribed to a Magistrate under the Magistrates' Act, Chap. 24 of the Laws of St. Vincent and the Grenadines.

To perform the duties of a Coroner.

To assist the Chief Magistrate/President, Family Court in the management of the Magistrates' Courts and the Family Court.

### Terms of Appointment

The appointment will be on a contractual basis, for a period of two (2) years, with an option to renew, if successfully completed. Gratuity at the rate of 25% of salary is paid upon successful completion of the contract. Private Practice is not allowed.

### Remuneration

Salary is payable at the rate of \$58,584 per annum in Grade 13.
