# OFFER OF SCHOLARSHIPS BY THE GOVERNMENT OF THE UNITED KINGDOM UNDER THE COMMONWEALTH SCHOLARSHIP AND FELLOWSHIP PLAN—2002 AWARDS

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO invites applications from nationals of the Republic of Trinidad and Tobago for scholarships being offered by the Government of the United Kingdom under the Commonwealth Scholarship and Fellowship Plan (CSFP)—2002 Awards.

- 2. These scholarships, tenable in the United Kingdom only, are awarded in all academic disciplines including Medicine, Dentistry and Allied Sciences and are for either—
  - (a) one-year taught masters or equivalent degrees or one (1) year of clinical training in Medicine or Dentistry; or
  - (b) Doctoral or equivalent degrees, of up to three (3) years duration.

Awards are not available to persons already holding a doctorate (or about to obtain one) or for pursuit of a first degree.
