PRIVATE BILL—AN ACT FOR THE INCORPORATION OF THE MT. LEBANON INDEPENDENT SPIRITUAL BAPTIST CHURCH THE SACRED CHOICE OF HEAVEN AND FOR MATTERS INCIDENTAL THERETO

NOTICE is hereby given under the provisions of Standing Order 76(3) (*b*)(i) of the Senate of a Bill entitled "An Act for the Incorporation of the Mt. Lebanon Independent Spiritual Baptist Church The Sacred Choice of Heaven and for matters incidental thereto", which it is proposed to introduce in the Senate.
