INTERNATIONAL PREQUALIFICATION NOTICE FOR TECHNICAL ASSISTANCE, MINISTRY OF HEALTH—CHANGE MANAGEMENT, HEALTH SECTOR REFORM PROGRAMME—IDB LOAN NO. 937/OC-TT

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) has received funds from the Inter-American Development Bank (IDB) to partially finance its Health Sector Reform Program (HSRP). To assist transition of the MOH from a "Provider" of health services to its new role as "purchaser" of health services with attendant strengthening of its legislative, regulatory, policy, health planning, programme monitoring and evaluation functions, an external full-time change management team with specific human resource management and management systems development expertise is being sought to assist the MOH. The objective of the consultancy is to evaluate the critical management, accountability and control systems within the Ministry of Health with a view to strengthening the Ministry's capacity to achieve and manage its changed "purchaser to provide" role.
