PUBLIC STATEMENT OF

THE MINISTRY OF WORKS AND TRANSPORT
IN COMPLIANCE WITH SECTIONS 7, 8 AND 9 OF

THE FREEDOM OF INFORMATION ACT, 1999 [FOIA]

In accordance with Sections 7, 8 and 9 of the Freedom of Information Act, 1999 [FOIA] the Ministry of Works and Transport is required by law to publish the following statements which list the documents and information generally available to the public.

The Act gives members of the public:-

- 1. A legal right for each person to access information held by the Ministry.
- 2. A legal right for each person to have official information relating to him/herself amended where it is incomplete, incorrect or misleading.
- 3. A legal right to obtain reasons for adverse decisions made regarding an applicant's request for information under the FOIA.
- 4. A legal right to complain to the Ombudsman and to apply to the High Court for Judicial Review to challenge adverse decisions made under the FOIA.

FUNCTION AND STRUCTURE OF THE MINISTRY OF WORKS AND
TRANSPORT

MISSION STATEMENT

The mission of the Ministry of Works and Transport is:

"To efficiently and effectively provide and maintain safe sea, air and land infrastructure for the improvement of the quality of life of the citizens of Trinidad and Tobago while promoting the development of our human resources"

STRUCTURE OF THE MINISTRY

The Ministry of Works and Transport is one of the largest Ministries of Government, and a major generator of employment opportunities in the country. The organization impacts directly and indirectly on all citizens of the country, and continually strives to enhance the quality and timely delivery of the services which it provides to the national community.

The Ministry is comprised of two main elements, namely, the Works component and the Transport component. The Works arm of the Ministry is associated with those Agencies and Divisions of the Ministry engaged in the provision and maintenance of physical infrastructure, while the Transport arm is associated with those departments engaged in the regulation of the Transport sector, and includes the Statutory Boards and similar bodies.

The details are as follows:-

WORKS COMPONENT

1. **HIGHWAYS DIVISION**

The Highways Division is responsible for the planning, design, construction, preservation, maintenance and repair of the existing road network which include main and secondary roads under the Ministry's authority. This responsibility also include maintenance works such as widening and altering road levels, upgrading verges and culverts and reconstruction of bridges.

2. **DRAINAGE DIVISION**

The Drainage Division is responsible for the development and maintenance of main watercourses, the provision and maintenance of irrigation systems, for land reclamation and for protection of lands against water, which includes coastal protection. The Division also provides advice to government agencies which implement and approve development projects.

3. **CONSTRUCTION DIVISION**

The Construction Division is responsible for the design, planning and executing of all works relating to the construction and rehabilitation of public buildings and facilities, including Government offices, quarters, rest houses etc..., the restoration of historical buildings and sites, and procurement and provision of furniture fittings and equipment for these buildings.

The Division is also responsible for providing building consultancy and advisory services to Government, and design consultancy and contract administration in the implementation of major building projects.

4. **MAINTENANCE DIVISION**

The Maintenance Division is responsible for maintaining, restoring and repairing the stock of Government properties, buildings, physical plant, furnishings and surrounding land.

5. MECHANICAL SERVICES DIVISION

The Mechanical Services Division is responsible for repairing, servicing, maintaining and transporting vehicles, plant and equipment belonging to the Ministry of Works and Transport and other Agencies in a reliable, effective, efficient and safe manner, and providing sound technical advisory services to other Government Departments and Agencies as and when required.

6. **PROPERTY AND REAL ESTATE SERVICES DIVISION**

The Property and Real Estate Services Division provides policy advice and monitoring services to the State in the area of real estate and property management. The Division is responsible for ensuring that the stock of government properties utilized for its operations is developed and maintained in a manner which ensures maximum utilization and economic returns from these assets. It also focuses on the provision of appropriately designed and configured workplaces and facilities that are consistent with the needs of a contemporary organisation.

The major functions of the Division include:-

- Rationalization of office space in Government owned buildings.
- > Allocation and sale of government quarters [private residences].
- Rental of office accommodation and private residences.
- Acquisition and lease of State lands under the jurisdiction of the Division.
- > Planning and monitoring services with respect to the construction of government offices
- Rental of government buildings to Non Governmental Organisations and other private organizations.
- Management of the State's Property Information Management Systems.
- Maintenance, security and safety of Government owned and leased buildings.

TRANSPORT COMPONENT

1. <u>CIVIL AVIATION DIVISION</u>

The Civil Aviation Division is the main regulatory agency in the Air Transport sector, and is responsible for supervising and monitoring air carrier operations in Trinidad and Tobago, and for approving flights and schedules. The Authority was established by Act No. 33 of 2000 and assumes all the functions and responsibilities of administering the safe, secure and economic operation of aircraft and aviation facilities in Trinidad and Tobago.

2. TRAFFIC MANAGEMENT DIVISION

The Traffic Management Division is responsible for the management and control of traffic on the roadways of Trinidad and Tobago. The Division also implements and monitors road traffic regulations, co-ordinates and implements efforts to reduce road traffic congestion, and ensures the effective operation of all traffic control devices, which include, road markings, signs and traffic signals.

3. MARITIME SERVICES DIVISION

The Maritime Services Division is the main regulatory agency in sea transport created to administer the provisions of the Shipping Act No. 24 of 1987. The Division plays a pivotal role in the development of the National Maritime Sector and represents the country's interest at the International Maritime Organization conferences. The Safety of Shipping in Trinidad and Tobago's waters as well as worldwide is the Division's primary objective. The Department is autonomous in the administration of its affairs and is classified as a 'public authority' under the Freedom of Information Act. Requests for information from this Department are

to be made directly to the assigned Designated Officer. [See Statement of Maritime Services Division in Gazette or Newspaper.]

4. <u>DEPARTMENT OF MOTOR-VEHICLE REGISTRATION AND CONTROL</u>

The Department of Motor-Vehicle Registration and Control was formerly called the Licensing Department. Its functions include registration, classification, licensing and inspection of vehicles, issuance of driving permits, law enforcement under the Motor Vehicle and Road Traffic Laws and collection of revenues associated with those activities. The Department is autonomous in the administration of its affairs and is classified as a 'public authority' under the Freedom of Information Act. Requests for information from this Department are to be made directly to the assigned Designated Officer. [See Statement of Department of Motor-Vehicle Registration and Control in Gazette or Newspaper.]

• General Procedure

Our policy is to answer all requests, both oral and written, for information. However, in order to have the rights given to you by the Freedom of Information Act [FOIA] (e.g. the right to challenge a decision if your request for information is refused), you must make your request in writing. The applicant must, therefore, complete the appropriate form [Request for Access to Official Documents] available in our Reception area, or from our Designated Officer, for information that is not readily available in the public domain. [See Section 7(1)(a)(vi)].

• Addressing Requests

To facilitate prompt handling of your request, please address it to the Designated Officer of the Ministry [See Section 7 (1) (a) (vi)].

• Details in the Request

Applicants should provide details that will allow for ready identification and location of the records that are being requested. If insufficient information is provided, clarification will be sought from the applicant. If you are not sure how to write your request or what details to include, communicate with our Designated Officer.

• Requests not handled under the FOIA

A request under the FOIA will not be processed to the extent that it asks for information which is currently available in the public domain, either from this Ministry or from another public authority {e.g. brochures and pamphlets etc....}

Responding to your Request

• Retrieving Documents

The Ministry is required to furnish copies of documents only when they are in our possession or we can retrieve them from storage.

• Furnishing Documents

An applicant is entitled to copies of information we have in our possession, custody or power. We are required to furnish only one copy of a document. If we cannot make a legible copy of a document to be released, we may not attempt to reconstruct it. Instead we will furnish the best copy possible and note its quality in our reply. Extra copies will be provided at the cost of reproduction.

Please note that we are not compelled to do the following:-

- (a) Create new documents
- (b) Perform research for you

Time Limits

General

The Freedom of Information Act sets certain time limits for us to decide whether to disclose the documents you have requested. If we fail to meet the deadlines, the FOIA gives you the right to proceed as if your request has been denied. If it appears that processing your request may take longer than the Statutory limit, we will acknowledge your request and advise you of its status. Since there is a possibility that requests may be incorrectly addressed or misrouted, you may wish to call or write to confirm that we have received the request and to ascertain its status.

• <u>Time Allowed</u>

We will determine whether to grant your request for access to information as soon as practicable but no later than 30 days as required by Section 15 of the FOIA.


