APPOINTMENT OF A PRIVATE WAREHOUSE

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs. Fabi Unique Distributors, West Mall, Westmoorings: Cosmetics, Perfumes, Toilet Soaps, Nail Enamels and Alcohol and such other goods as I may subsequently approve.

SCHEDULE

An enclosed area numbered as No. 146 and known as Fabi's In Bond Shop and located on the ground floor of West Mall Plaza, Westmoorings.

The area measures 9 metres by 6 metres comprising a total surface area of 54 square metres. The perimeter walls are constructed of concrete and the entrance and exit are situated on the northern side.

It is bounded on the north by Stetchers Limited and the Atrium of the Mall, on the south by R.I.K. Bookstore, on the west by Jaram Jewellers Limited and on the east by Popin Card Shop.


