CONSULTANCY SERVICES TO ASSIST WITH THE ANALYSIS OF DATA FROM THE 1997 SURVEY OF LIVING CONDITIONS AS WELL AS WITH CAPACITY BUILDING WITHIN THE SOCIO-ECONOMIC POLICY PLANNING DIVISION, MINISTRY OF PLANNING AND DEVELOPMENT—GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO

The Government of the Republic of Trinidal and Tobago wishes to engage the services of a team of consultants to assist in developing the capacity of key Government Ministries to monitor and evaluate living standards in the country on a continuous basis. The focal point for the consultancy will be the Socio-Economic Policy Planning Division, Ministry of Planning and Development. The consultants will be required to undertake intensive training of the Government Counterpart Team and to produce the 1997/1998 Trinidad and Tobago Survey of Living Conditions (SLC) Report. The expected duration of the consultancy is three months.
