By virtue of the provision of section 16 of the Architecture Profession Act, 1992 a person who is not a Registered Architect shall not—

1. Use any title or description that leads to the belief that he is a registered architect;
2. Advertise himself as a registered architect;
3. Act in a manner so as to create or induce the belief that he is a registered architect; or
4. Sign or stamp any plans, drawings, designs or specifications purporting to be acting in the capacity of such registered architect.

Section 26(2) of the Act provides for a fine of \$5,000.00 or to imprisonment for two years or to both such fine and imprisonment for any contravention of the said section 16.
