APPLICATION FOR A PIPELINE LICENCE BY THE NATIONAL GAS COMPANY OF TRINIDAD AND TOBAGO

Pursuant to section 7 of the Petroleum Act, Chap. 62:01, notice is hereby given that an application for a pipeline licence has been made by The National Gas Company of Trinidad and Tobago to construct, install, maintain and operate a pipeline as described in the attached schedule along the route indicated in the attached map marked "A".

Any person may object to the issue of the above-mentioned licence on the ground that it is inconsistent with, or would interfere with, rights held by him under the Petroleum Act, Chap. 62:01.

All objections to the grant of the Pipeline Licence to the afore-mentioned applicant may be lodged with the Minister of Energy and Energy Industries within thirty days (30) days of the date hereof at Government Offices, Riverside Plaza, Level 9, Besson Street, Port-of-Spain.

SCHEDULE ABOVE REFERRED TO—DESCRIPTION OF PIPELINE

Route The 609mm (24-inch) diameter pipeline is to commence at the NGC's Phoenix Park Intermediate

Station and proceeds west (as a buried line) across the Southern Main Road and North Sea Drive. The line ties in to NGC's existing pipeline network approximately ten (10) metres west of North Sea

Drive.

Length 160 metres (520 feet).

Specification of Pipeline Nominal Diameter 609 mm (24-inch), wall thickness 10.3 mm (0.406 inch), grade of pipe API 5L (X52).

Material of Construction Carbon Steel.

Coating Specification External: Asphalt-based bituminous compound, reinforced with fibre-glass fabric.

Internal: High-solids amine-cured epoxy.

Fabrication The line will be welded together in accordance with API Code 1104 and subjected to 100% radiographic

inspection. All welded joints will be cleaned and primed with a fast drying synthetic primer and

wrapped with a protective tape.

Cathodic Protection The pipeline will be incorporated into an existing "impressed current" Cathodic Protection System.

Depth of Line The pipeline will be buried at a minimum depth of 1.2 m (4 feet) below the surface on normal grade,

and a minimum of $1.2\,\mathrm{m}$ (4 feet) below unpaved drainage with a concrete slab at $0.6\,\mathrm{m}$ (2 feet). Plastic Warning Tape with the words "DANGER GAS LINE" will be laid along the entire length of

the pipeline approximately 0.6 m (2 feet) above the line.

Crossings The pipeline will cross underneath the Southern Main Road and North Sea Drive, inclusive of

associated shoulders and drains. Buried utilities may also be crossed, the exact location of which will be determined prior to construction. In addition, the proposed line will cross an existing

(NGC-owned and operated) 609 mm (24-inch) pipeline.

Fluid for Transmission Natural Gas.

Operating Pressure 24.1 bars (350 psig).

Design Pressure 51.7 bars (750 psig).

Estimated Capacity By the addition of the proposed pipeline there will be an increase in capacity of the pipeline system

from 1380 MMscf/d to 1400 MMscf/d.


