CONDITIONS OF SALE

- 1. Duty equivalent to thirty per cent (30%) of the purchase price shall be payable to the Customs and Excise Division.
- 2. Fifteen per cent (15%) VAT shall be payable to the Customs and Excise Division of the Ministry of Finance.
- 3. Payment must be made to the Port Authority on the day of sale either by cash or certified cheque.
- 4. Persons failing to comply with condition (3) above will not be entertained at future Auction Sales held by the Authority.
- 5. Items, the sale of which has been disallowed by other Government Agencies, shall be removed from the list of articles to be auctioned.
- 6. All auctioned cargo must be removed from the Authority's Compound by the respective buyers within ten (10) days subsequent to the Auction Sale at which they were purchased.
- 7. Items sold but not claimed and removed by the respective buyers, as per (6) above, shall be resubmitted for sale by the Authority at the next Auction Sale.
