CONDITIONS OF SALE

AMENDMENTS TO THE RULES OF RACING

THE TRINIDAD AND TOBAGO RACING AUTHORITY gives notice of the following amendments to the Rules of Racing, 2003:

Rule 36—Owners, Partnerships, Syndicates, Recognised Companies, Leases and Contingencies

21. All registration of owners, partnerships, syndicates and recognised companies appearing in these Rules expire on 31st December each year, and must be renewed annually with the Authority on the prescribed form. Registration and renewal of owners, partnerships, syndicates and recognised companies can also be completed for multiple terms up to three years with the relevant fee applicable to the time period, i.e. by two for two year terms and three for three year terms.

Rule 56—Prizes

7(b)(ii) In any race which the Prize Money is less than \$25,000., jockeys will receive 10% and apprentices 5% on First Place, and also the following:
