APPOINTMENT OF A PRIVATE WAREHOUSE

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Joseph A. Renaud, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export of the following goods, as shall be warehoused by or in the private warehouse of Messrs. Fashion Optics Limited of Ray Cool Duty Free Shop, Ground Floor, Piarco International Airport—viz. Sunglasses, accessories and display and such other goods as I may subsequently approve.

An enclosed area located on the ground floor of Piarco International Airport and covering a surface area of 38 square metres with dimensions of 4.7276 metres by 8.0363 metres.

The perimeter walls and ceiling of the shop, numbered A1.111.01, are constructed from gypsum and access is gained by an aluminum door on the western side.

The area is bounded on the west by an open thoroughfare leading to the Customs Baggage Room, on the east by the outer terminal area and the Royal Castle Food Outlet, on the south by Maraj and Sons, on the north by the outer terminal area leading to the Airline Check-in Counters.
