## PUBLICATION OF BILL

### AN ACT FOR THE INCORPORATION OF THE NATIONAL CARNIVAL BANDS ASSOCIATION OF TRINIDAD AND TOBAGO ASSOCIATION

1. Public notice is hereby given in accordance with standing Order No. 83(3)(b)(i) of the House of Representatives that it is amended to introduce in the House of Representatives the above-mentioned Bill.

2. Notice of the intended introduction of the Bill is given in the Trinidad and Tobago Gazette and copies of the Bill may be purchased from the Government Printer.

3. The object of the Bill, among other things, is to incorporate the National Carnival Bands Association of the Grand Stand, Queen's Park Savannah, Port-of-Spain in order to enable or to hold property and to otherwise carry out its aims and objectives.

4. Any person wishing to be heard in opposition to the Bill must lodge with the Clerk of the House a petition showing the nature of his objections to the Bill and stating whether his objections extend to the whole or some part of the preamble or to the clauses of the Bill and praying that he may be heard by himself or his counsel against the Bill.

(COMMISSIONS OF ENQUIRY ACT, CHAP. 19:01)

IN ACCORDANCE with section 15 of the Commissions of Enquiry Act, Chap. 19:01 of the Laws of the Republic of Trinidad and Tobago, it is hereby notified for general information that His Excellency the President Professor GEORGE MAXWELL RICHARDS, T.C. C.M.T, Ph.D, in the exercise of the powers vested in him under section 2 of the said Act, has issued a Commission appointing the persons named hereunder as Commissioners to enquire into the operation and delivery of Public Health Care Services in Trinidad and Tobago.

The terms of reference of the Commission are:

- (i) To enquire into the operation and delivery of Public Health Care Service and the adequacy and quality of such services with special reference to:—

The adequacy of existing Public Health Care Facilities to meet the needs of the public including the special needs of the elderly, visually impaired and handicapped;

The adequacy of the quality of the health services provided by professional and non-professional staff of Public Health Care Facilities;

The Adequacy of the number, qualifications and training of professional and non-professional staff of Public Health Care Facilities;

The capabilities of the management of professional and non-professional staff of Public Health Care Facilities to meet the demands of the public for the delivery of quality Health Care,

The adequacy of medical equipment and availability of drugs and pharmaceuticals to meet the health care needs of the public;

The circumstances surrounding the procurement process and the award of contracts generally in the Public Health Sector;

The criteria used for the rendering of a proper service to patients and whether or not these are in the best interest of the clients, that is the patients, the Regional Health Authorities and the Ministry of Health;

What machinery exists for receiving and addressing effectively the complaints and concerns of the public in relation to the adequacy and quality of health services, including professional attention, provided at Public Health Care Facilities and how have complaints been dealt with in the past.

The number and nature of the complaints received from members of the public concerning the adequacy and quality of health services, including professional attention, provided at the Health Care Facilities in recent times, what has been done to address those complaints and if there have been omissions or delays in addressing complaints, the reason for such omissions or delays.

- (ii) To make such observations and recommendations arising out of its deliberations as the Commission may deem appropriate.

His Excellency the President Professor GEORGE MAXWELL RICHARDS further directed that:

Hector McClean *Esquire* be the Chairman of the Commission and that with due diligence and dispatch the Commission report to him within a period of not more than six (6) months from the date of the first sitting;

The enquiry be held in public but the Commissioners nevertheless be entitled in their discretion to sit in private;

A quorum of the Commission should consist of three (3) Commissioners; and

The Secretary to the Commission be Ambassador Patrick Edwards.
