RESTRICTIONS ON IMPORTATION OF LIVE CATTLE, BEEF AND BEEF PRODUCTS FROM THE UNITED STATES OF AMERICA

THE PUBLIC is hereby notified that effective 24th December, 2003, the Ministry of Agriculture, Land and Marine Resources has imposed temporary restrictions on the importation of live cattle, beef and beef products from the United States of America.

This has become necessary as a result of the discovery of *Bovine Spongiform Encephalopathy* ("mad cow disease") in the United States of America.

This suspension on the importation of live cattle, beef and beef products from the United States of America will be in effect for one (1) month when this decision will again be reviewed and the public will be further advised.
