TENDERS FOR SCHEDULE 20—SUPPLY, TRANSPORT, SPREAD AND ROLL OF HOT ASPHALT MIX TO JOB SITES OF CENTRAL GOVERNMENT DIVISION, LOCAL GOVERNMENT BODIES, TOBAGO HOUSE OF ASSEMBLY AND CERTAIN STATUTORY BODIES ON AN "AS AND WHEN REQUIRED BASIS" FOR THE PERIOD 31st DECEMBER, 2004

TENDERS are invited for Schedule 20—Supply, Transport, Spread and Roll of Hot Asphalt Mix to job sites of Central Government Divisions, Local Government Bodies, the Tobago House of Assembly and certain Statutory Bodies on an "as and when required basis" for the period ending 31st December, 2004.

Tender documents may be perused/collected during normal working hours at the Central Tenders Board's Office, 116, Frederick Stret, Port-of-Spain.

Prospective tenderers will receive the hard copy of the following documents only:

- (i) Tender Forms.
- (ii) Instruction to Tenderers.
- (iii) Conditions of Contract.

The Specification document will be delivered on  $2^{1/2}$  Floppy Diskette. Interested parties are therefore required to provide a blank diskette to the Board's Office in order to download this document.

Tender documents can also be perused on the Ministry of Finance website—www.finance.gov.tt.

Tenderers must attached the following to their tender:

- (i) Value Added Tax Clearance Certificate.
- (ii) A Valid Income Tax Certificate dated not more than six (6) months prior to the closing date of the tender.
- (iii) An official receipt showing that a deposit of one hundred dollars (\$100.00) has been paid to the Director of Contracts, Central Tenders Board Division, 116, Frederick Street, Port-of-Spain.

The unsuccessful tenderers will be refunded their deposits after awards are made.

The successful tenderer/s will be required to pay a Cash Performance Deposit or provide a Bond amounts varying between \$1,000.00 and \$10,000.00 depending on the value of the contract. Cash Performance Deposits or Bonds must be provided within fourteen (14) days of the date of the Letter of Award.

The Performance Deposit/Bond will be retained until the end of the contract period and may be used to defray any excess costs that may be incured by Government because of the contractor's failure to supply and/or perform under the contract.

Failure to pay the Performance Deposit to provide the Bond within the stipulated period may result in the contract being declared null and void and the Tender Deposit forfeited.

Sealed tenders in Duplicate on the approved Forms will be received up to 1.00 p.m. on Thursday 12th February, 2004. These envelopes must be addressed to the Director of Contracts, Central Tenders Board, 116, Frederick Street, Port-of-Spain and marked on the outside. "Schedule 20—Supply, Transport, Spread and Roll of Hot Asphalt Mix for the period ending 31st December, 2004" and must be deposited in the Brown Tenders Box located in the lobby of the Board's Office.

Tenders will be opened shortly thereafter. The tenderer or his representative may be present at the opening.

Only tenders submitted on the official tender form (in hard copy) will be considered. Tenders submitted in any other form other than the hard copy of the official tender form will not be accepted.

Late tenders will not be considered in any circumstances.

The Board does not bind itself to accept the lowest or any other tender.
