Proposals must be accompanied by valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender. In addition, a Certificate of Compliance issued in accordance with the National Insurance Act must be submitted.

One (1) original and six (6) copies each of the Technical and Financial Proposals should be placed in separately sealed envelopes clearly marked: "Proposals for Consultancy Services for the Design and Supervision of the Construction of nine (9) Primary Schools and the Modernisation of nine (9) Special Schools for the Ministry of Education". "Package A, B, C or D", and addressed to Chairman, Central Tenders Board at the above address. The Firm's name must be included on the Envelopes of the Financial Proposals.
