## SUBMISSION OF PROPOSALS BY NGOs, CBOs, FBOs AND COMMUNITY GROUPS FOR HIV/AIDS RELATED PROJECTS

### PREVENTION AND CONTROL PROJECT- LOAN NO. 7184-TR

The Government of the Republic of Trinidad and Tobago (GORTT) in its efforts to prevent and control the spread of the HIV/AIDS epidemic has developed a five year National Strategic Plan (NSP) 2004-2008 as the guide to the national response to HIV/AIDS. The NSP has two overarching goals:

- i. to reduce the incidence of HIV infections, and
- ii. to mitigate the negative impact of HIV/AIDS on persons infected and affected.

The NSP proposes five components:

- 1 Prevention of the spread of HIV/AIDS transmission,
- 2 Treatment, care and support,
- 3 Advocacy and human rights,
- 4 Surveillance and research
- 5 Programme management, coordination and evaluation

To achieve the goals of the NSP, the GORTT has received a loan from the International Bank for Reconstruction and Development (IBRD) towards the implementation of the HIV/AIDS Prevention and Control Project. This project would be implemented through an institutional and management structure that would permit the widest participation of non-governmental organisations (NGOs,CBOs,FBOs) and community groups to provide important services for the prevention of the spread of HIV and care for People Living With HIV/AIDS (PLWHA), and the provision of education, awareness and behaviour modification advice to selected targeted audiences.

Interested Groups are invited to submit proposals for financial assistance for HIV/AIDS related projects to the National AIDS Coordinating (NACC) before **June 15 2004**.
