APPOINTMENT OF CUSTOM AREAS

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Joseph A. Renaud, Acting Comptroller of Customs and Excise, acting under the provisions of section 2 of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area for the storage of machinery, equipment, raw materials, semi-manufactured goods and other ingredients imported or taken out of bond by Advance Tyres Systems Limited of 341, Union Road, Marabella, for the retreading of tyres or other goods as may subsequently be approved.

SCHEDULE

An area with dimensions 18 metres by 6 metres totalling 104 metres squared enclosed with BRC wire ascending to the roof, access effective through a steel door on the southern side.

The enclosed area occupies the northern section of the top floor of a two storey building owned by Advance Tyre Systems Limited situate at 217, Union Road, Harmony Hall, Marabella.

Also occupying an adjacent area on the above stated top floor is an area designated: "COLD ROOM" dimensions 6 m x 3 m x 3 m. The wall is of concrete on the western side and wooden on the other three sides. The ceiling which does not meet the roof is also wooden.

The above property which houses these above two areas is bounded on the north by F. Khan Machine Shop, on the south by Union Road, Marabella, on the east by the Sadick Baksh Building and on the west by Fen Mohammed Stores Warehouse.

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Joseph A. Renaud, Acting Comptroller of Customs and Excise, acting under the provisions of section 2 of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area for the storage of machinery, equipment, raw materials, semi-manufactured goods and other ingredients imported or taken out of bond by Antillean Seafoods Limited of D1 + D2 Demerara Drive, Pt. Lisas, for the processing of fish and fishery products or other goods as may subsequently be approved.

SCHEDULE

An enclosed area comprising 4,800 sq. ft. (40' x 120').

The above demarcated area occupies part of Building A on Lot D1 + D2 situate in the Point Lisas Industrial Estate at Demerara Road, Pt. Lisas.

The building is constructed of walls of concrete blocks, roofing of galvanized sheets and doors of metal with entrance on Demerara Road, facing north.

The premises are bounded by Pacific Avenue on the west, south by Lands occupied by Jupiter Plastics, on the east by Demerara Road No. 2, with the entrance on Demerara Road facing north.

The building is fenced by chain link wire and steel posts with a gated entrance on Demerara Road No. 1.
