TRINIDAD AND TOBAGO RACING AUTHORITY

AMENDMENT TO THE RULES FOR REGISTRATION OF HORSES

THE TRINIDAD AND TOBAGO RACING AUTHORITY gives notice of the following amendments to the Rules for Registration of Horses:

Rule 8—Vaccination is amended in the following manner:

Include under 1(a) West Nile Virus

(b) First inoculation . . . Delete "and" before tetanus. Include after "Tetanus".—"and West Nile Virus".

Under 11(a) Include new category—West Nile Virus

(b) Include—First inoculation for West Nile Virus at 3 months of age.

Second inoculation for West Nile Virus at 5 months.

A booster inoculation for West Nile Virus shall be given semi-annually.

The above amendments to the Rules for Registration of Horses were approved at a meeting of the Trinidad and Tobago Racing Authority held on Tuesday 12th July, 2005.
