THE TRINIDAD AND TOBAGO RACING AUTHORITY gives notice of the following amendments to the Rules of Racing:

INTERPRETATION

Rule 2 is amended to include the following:

"Cheekpieces"—means two strips of Sheepskin or any other similar material or device which is attached to the cheekpiece of the bridle.

Rule 34(9)—Include after tongue strap—"or cheekpieces".

Rule 49(17)—Line 2—Include after tongue strap—"or cheekpieces".

Rule 49(18)—Line 1—Include after tongue strap—"or cheekpieces".

Rule 49(19)—Line 1—Include after tongue strap—"or cheekpieces".

The above amendments to the Rules of Racing were approved at a meeting of the Trinidad and Tobago Racing Authority on Tuesday 18th October, 2005.
