I HEREBY grant to Mr. Keith Belgrove of Cemetery Management Company a thirty (30) year licence to operate a Private Burial Ground. This is subject to the terms and conditions of the licence agreements.

**TERMS AND CONDITIONS OF LICENCE RELATING TO THE OPERATION OF A
PRIVATE BURIAL GROUND**

1. (a) The licence issued to Cemetery Management Limited under the Burial Grounds Act shall be valid for a period of thirty (30) years and shall be for the operation of a private burial ground called Orange Grove Memorial Park, situate at 10, Orange Grove Road, Trincity, adjoining the already operational Belgrove's Memorial Center Funeral Home and Crematorium. The said licence may, however, be suspended or revoked by the Minister if Cemetery Management Company is found to be in breach of the Private Burial Grounds Regulations, Chap. 30:50 of the Laws of Trinidad and Tobago, or if the Minister deems that such suspension or revocation is necessary in the public interest.
- (b) The licence fee shall be the sum of \$100,000.00 for the relevant thirty (30) years and shall be paid to the Tunapuna/Piarco Regional Corporation, one (1) month prior to the opening of the Private Burial Ground.
- (c) The licensee shall give to the Minister at least six (6) months notice in writing of its intention to renew the said licence.
2. In the event the Licensee proposes to terminate the Private Burial Ground as a going concern they shall give to the Minister no less than six (6) months notice in writing of such intention and provide an adequate scheme also in writing for future succession and management of the cemetery for the Minister's consideration and approval.
3. The Licensee shall notify the Minister in writing of the general terms and conditions pertaining to the obligations and the liabilities between themselves and other parties regarding the burial of deceased persons, such obligations and liabilities shall be in accordance to existing law.
4. The Minister and/or his authorized agent shall annually inspect the Burial Ground established and may give such directions as may be necessary.
5. The Licensee shall record details of each burial in accordance with the draft register hereto annexed and marked "A".
6. The Licensee shall ensure the following:
 - (i) The Minister and the Tunapuna Piarco/Regional Corporation are furnished with a plan of the Burial Ground.
 - (ii) Each burial conforms to specifications as laid out by the Licensee.
7. The Licensee shall submit a return of all burials in their Private Burial Ground to the Tunapuna/Piarco Regional Corporation every three (3) months.
8. No body/or remains of a body interred in the Private Burial Ground shall be disinterred or removed except—
 - (i) Upon an order of a Coroner under the Coroner's Act or, any judicial officer or competent court or authority;
 - (ii) By permission granted by the Minister.
9. The application to the Minister to disinter or remove a body shall be made by an interested party in writing and shall state all necessary particulars including name, cause of death, address of relatives and the reason for disinterring or removing the body.
10. The Licensee shall comply with all other laws and regulations in relation to the operation of the Private Burial Ground, and or such directions or orders given by the Minister from time to time.
