# PRIVATE BILL—AN ACT FOR THE INCORPORATION OF THE CHILD WELFARE LEAGUE OF TRINIDAD AND TOBAGO

PUBLIC NOTICE is hereby given in accordance with Standing Order No. 76(3)(b)(i) of the Senate that it is intended to introduce in the Senate the above-mentioned Bill.
