AUCTION SALE OF UNCLEARED CARGO

THE PORT AUTHORITY OF TRINIDAD AND TOBAGO wishes to advise that under section (3) of Act No. 46 of 1978 *Re: Disposal of Uncleared Goods Act*, Mr. Gary Gregoire, Auctioneer, has been instructed to sell, by public auction, uncleared cargo stored at Shed No. 9 located on the Authority's Compound.

CONDITIONS OF SALE

1. Duty equivalent to thirty percent (30%) of the purchase price shall be payable to the Customs and Excise Division.
2. Fifteen percent (15%) VAT shall be payable to the Customs and Excise Division.
3. Payment must be made to the Port Authority on the fall of the hammer either by Cash, Certified Cheque, Debit Card (LINX) or Credit Card.
4. Persons failing to comply with condition (3) above will be debarred from continued participation in the current as well as any future auction sale held by the Authority.
5. All lots will be sold on an "as is" "where is" basis.
6. Items, the sale of which has been disallowed by other Government Agencies, shall be removed from the listing of cargo to be auctioned.
7. All auctioned cargo must be removed from the Authority's Compound by the respective buyers within ten (10) days subsequent to the auction sale at which they were purchased.
8. Items sold, but not claimed and removed by the respective buyers, as per (7) above, shall be resubmitted for sale by the Authority at the next auction sale.
