CLOSING DATE FOR NOMINATION OF CANDIDATES FOR THE 22ND ANNUAL GENERAL MEETING, 2008

All Attorneys-at-law are advised that—

- 1. The twenty-second Annual General Meeting of the Law Association of Trinidad and Tobago will be held on Friday 14th March, 2008.
- 2. The closing date for Nomination of Candidates for election of Officers and Members of Council is Thursday 14th February, 2008. Nominations for the position of President, Vice-President, Treasurer and fifteen (15) Ordinary Members (10 seniors and 5 juniors) must be made in writing on the prescribed form.
- 3. Nomination Forms are obtainable in Port-of-Spain from the Secretariat of the Law Association, in Arima from Mr. Lal Krishna Doodnath, in Chaguanas from Ms. Veena Badrie-Maharaj, in San Fernando from Mr. Hendrickson Seunath S.C., in Sangre Grande from Mr. Verne Richards and in Tobago from Mr. Christo Gift.
- 4. Pursuant to paragraph 9(2) of Part II of the Legal Profession Act, 1986 only practitioner members who pay their annual subscription to the Law Association are eligible—
 - (a) to attend and vote at a general meeting or at an election of members of the Council; or
 - (b) to be elected to the Council.
- 5. Candidates as well as persons nominating them must be practitioner members of the Association. Every nomination of a candidate for election to the Association and the Council shall be signed by not less than five practitioner members and endorsed by the candidate.
