APPOINTMENT OF A TRANSIT SHED

(Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of section 2 of the Customs Act, Chap. 78:01, I, Fitzroy A. The premises to house the Aviation Business Limited South Terminal Air Cargo Transit Shed, situate at Piarco International Airport, in the ward of Tacarigua, constituting part of the old Passenger Terminal Building, Piarco International Airport, Piarco.

It comprises two (2) floors leased by Aviation Business Limited from the Airports Authority, located in the portion of the old Passenger Terminal Building that was formerly occupied by British West Indian Airways (B.W.I.A.), lying west of the area formerly known as the Tobago Terminal, with a total floor space of two thousand, nine hundred and seventy-one point five square metres (2971.5 m²) and constructed essentially of concrete blocks in a steel superstructure, with a roof of steel frame covered with galvanized iron sheets.

The building is rectangular in shape, comprising an upper floor to accommodate offices, and a ground floor for the storage of cargo as well as to provide further office accommodation. It is bounded on the north by the Piarco Airport Ramp and Runway, on the south by the Golden Grove Road, on the east by lands owned by the Airports Authority of Trinidad and Tobago, and on the west by other parts of the old Passenger Terminal Building.

SCHEDULE II—PRIVATE WAREHOUSE

An area of 65.4 square metres [9.75 m (L) x 6.71 m (W) x 3.66 m (H)] situate within the premises described above in Schedule I.
