Court (50%)

- 1. Represents the Board of Inland Revenue at the Tax Appeal Board in the capacity of both instructing and advocate attorney when defending tax assessments raised by the Board of Inland Revenue.
- 2. Appears with the Board's more senior legal officers of the Board if the matters reaches Court of Appeal level.
- 3. Represents the Board of Inland Revenue in Judicial Review proceedings and Constitutional Motions.
- 4. Prosecutes taxpayers who commit offences under the various tax Acts in the Magistrate Court.
- 5. Conducts both criminal and civil matters.

COMPENSATION in the above matter having been deposited with me under section 8 of the Workmen's Compensation Act, persons claiming to be the dependants of the said Diaram Ramtahal are hereby required to appear before the Commissioner on Monday the 25th day of February, 2008, at 10.00 o'clock in the forenoon at the Hall of Justice, Port-of-Spain, when the Commissioner shall proceed to determine the distribution thereof.

Proof of relationship of dependants to the deceased workman will be required by the Commissioner to be furnished by claimants at the enquiry. Such proof to be in the form of certificates of birth and of marriage as in the circumstances be necessary.

A claimant for funeral expenses of the deceased must submit and prove his claim to the Commissioner on or before the 25th day of February, 2008.
