Application for Certificates for New Licences and Renewals must be submitted to the Clerk of the Peace, Magistracy, St. George West, Secretary of the Licensing Committee, on or before 21st February, 2008 and 28th February, 2008 for new and renewals respectively.

Applicants for Certificates for New Licences must submit:

- (1) Five (5) copies of the application on the prescribed forms.
- (2) Three (3) copies of the floor plan of the premises to be licensed.
- (3) A fee of forty dollars (\$40.00); and
- (4) Board of Inland Revenue (B.I.R.) File Number.

Applicants for Renewals must submit:

- (1) Three (3) copies of the application.
- (2) Current Licence (Production Only).
- (3) Board of Inland Revenue (B.I.R.) File Number.
