## NOTICE OF SUBMISSION FOR PUBLIC COMMENT OF THE DRAFT WASTE MANAGEMENT RULES, 2008

NOTICE is hereby given that the Minister of Planning, Housing and the Environment ("the Minister") in exercise of the power granted to her by section 26(1) of the Environmental Management Act, 2000 ("the Act") proposes to make the Draft Waste Management Rules, 2008 ("the Draft Rules").

The Draft Rules include rules for procedures for the registration of generators of hazardous wastes and seeks to ensure that no person will carry out any activity relating to storage, treatment or disposal of hazardous wastes without a waste handling permit, nor will any waste handling facility be operated without a licence. The Draft Rules also provide for the safe transport (including import and export), storage and disposal of hazardous wastes.

And take notice that the Minister pursuant to section 27 of the Act and in accordance with section 28 of the Act now submits the Draft Rules for public comment.

And take notice that the Environmental Management Authority ("the Authority") has pursuant to section 28(1)(b) of the Act, established an Administrative Record that includes a written description of the proposed action, the major environmental issues involved in the matter under consideration, copies of relevant documents or other supporting materials which the Authority believes would assist the public in developing a reasonable understanding of those issues and a statement of the Authority's reasons for the proposed action.
