MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE
MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)
(NO. 4) REGULATIONS, 2008

1. These Regulations may be cited as the Traffic Control Citation
(Experimental Scheme) (No. 4) Regulations, 2008.

2. These Regulations shall have effect from Monday 27th October, Duration
2008 to Monday 26th January, 2009.

PART I

NEW TOWN—PORT-OF-SPAIN

3. Motorists shall proceed in a northerly direction on Maraval One-way
Road, between Tragarete Road and Sweet Briar Road, from 6.00 a.m. to traffic
6.00 p.m. from Monday to Friday, except on public holidays.

4. Motorists shall not—

(a) park or wait on the western side of Maraval Road, between
Herbert Street and Tragarete Road, from 6.00 a.m. to
6.00 p.m. from Monday to Friday, except on public holidays;
and

(b) park on the eastern side of Maraval Road, between
Herbert Street and Tragarete Road, from 6.00 a.m. to
6.00 p.m. from Monday to Friday, except on public holidays.

Parking
prohibited

PART II

PORT-OF-SPAIN

5. Parking is prohibited on—

(a) Queen Street, between Richmond Street and St. Vincent
Street;

(b) Edward Street, between Sackville Street and Independence
Square North;

Parking
prohibited

- (c) Richmond Street, between London Street and Independence Square North;
- (d) Dundonald Street, between Queen's Park West and Albion Street; and
- (e) the northern side of Albion Street, between Dundonald Street and Chancery Lane.

Two-way traffic 6. Motorists shall proceed in both directions on Queen Street, between Richmond Street and St. Vincent Street.

PART III

CHAMPS FLEURS/CUREPE

- Reversible lanes 7. Motorists shall proceed on the centre lane in—
- (a) a westerly direction on Eastern Main Road, between Abercromby Street and Mendez Drive, between 5.00 a.m. and 2.00 p.m. from Monday to Friday, except on public holidays;
 - (b) an easterly direction on Eastern Main Road, between Abercromby Street and Mendez Drive, between 2.00 p.m. and 9.00 p.m. from Monday to Friday, except on public holidays;
 - (c) a westerly direction on Eastern Main Road, fifty metres west of the Uriah Butler Highway and Mt. Lambert Road, between 5.00 a.m. and 2.00 p.m. from Monday to Friday, except on public holidays; and
 - (d) an easterly direction on Eastern Main Road, fifty metres west of the Uriah Butler Highway and Mt. Lambert Road, between 2.00 p.m. and 9.00 p.m. from Monday to Friday, except on public holidays.

PART IV

ARIMA

- Parking prohibited 8. Parking is prohibited on—
- (a) Queen Street, from Sorzano Street to Devenish Street; and
 - (b) Green Street, from Woodford Street to Queen Street.

- One-way traffic 9. Motorists shall proceed in—
- (a) a southerly direction along St. Joseph Street, between Church Street and Broadway;
 - (b) a northerly direction along St. Joseph Street, between Hollis Avenue and Broadway;

- (c) a northerly direction along Woodford Street, between Hollis Avenue and Church Street;
 - (d) a southerly direction along Queen Street, between Church Street and Hollis Avenue;
 - (e) a westerly direction along Rose Street, between Cocorite Road and King Street;
 - (f) an easterly direction along Green Street, between King Street and Cocorite Road;
 - (g) a westerly direction on Broadway, between Queen Street and King Street;
 - (h) an easterly direction along Sorzano Street, between King Street and Prince Street;
 - (i) a westerly direction along Sanchez Street, between Prince Street and King Street;
 - (j) an easterly direction along Church Street, between King Street and Prince Street;
 - (k) a southerly direction along Moreno Street, between Guanapo Road and Columbus Street;
 - (l) a northerly direction along Thano Lane, between Columbus Street and Guanapo Road;
 - (m) a westerly direction along Broadway, between Guanapo Road and Queen Street; and
 - (n) a southerly direction along Prince Street, between Sorzano Street and Broadway.
10. Motorists shall proceed in both directions along Industry Lane. Two-way traffic
11. Maxi-taxis shall not proceed in— No entry to maxi-taxis
- (a) an easterly direction on Hollis Avenue from St. Joseph Street;
 - (b) a westerly direction on Lopez Street;
 - (c) a westerly direction on Rose Street, between St. Joseph Street and King Street;
 - (d) an easterly or westerly direction on Green Street, between King Street and St. Joseph Street;
 - (e) an easterly direction on Sorzano Street, between King Street and St. Joseph Street; and
 - (f) a westerly direction on Sanchez Street, between St. Joseph Street and King Street.

PART V

SANGRE GRANDE

Parking
prohibited

12. Parking is prohibited on—

- (a) Brierly Street, between Picton Road and Ojoe Road;
- (b) Foster Road, between Brierly Street and Riverside Complex;
- (c) Old Post Office Road, between Eastern Main Road and Railway Road No. 1; and
- (d) Eastern Main Road, between Ojoe Road Roundabout and George Street on the—
 - (i) southern side on Monday, Wednesday and Friday; and
 - (ii) northern side on Tuesday, Thursday and Saturday.

One-way
traffic

13. Motorists shall proceed in—

- (a) a westerly direction on Eastern Main Road, between Wallenvale Road and Guaico-Tamana Road, Guaico Junction, from 6.00 a.m. to 9.00 a.m. and 2.00 p.m. to 6.00 p.m. Monday to Friday, except public holidays;
- (b) a northerly direction on Railway Extension Road, between Eastern Main Road and Railway Road;
- (c) an easterly direction on Railway Road, between Eastern Main Road, Guaico Junction and Picton Road;
- (d) a southerly direction on Royal Castle Corner Road, between Railway Road No. 1 and Eastern Main Road;
- (e) an easterly direction on Brierly Street, between Picton Road and Toco Road;
- (f) a northerly and westerly direction on Henderson Street, between Toco Road and Foster Road;
- (g) a northerly direction on Guaico Village Street No. 1, between Railway Road and Eastern Main Road;
- (h) a southerly direction on Guaico Village Street No. 3, between Eastern Main Road and Railway Road Extension;
- (i) an easterly direction on River Road, between Ojoe Road and Foster Road;
- (j) a northerly direction on Guaico Village Street No. 4, between Railway Road Extension and Eastern Main Road;

- (k) a southerly direction on George Street, between Eastern Main Road and Juteram Street;
- (l) an easterly direction on Canton Street, between Paul Street and George Street;
- (m) a westerly direction on Oxford Street, between George Street and Paul Street;
- (n) a southerly direction on Cunapo Southern Road, between Eastern Main Road and Mary Street;
- (o) an easterly direction on Mary Street, between Paul Street and George Street;
- (p) a northerly direction on Michael Street, between Eastern Main Road and Brierly Street; and
- (q) a southerly direction on Andre Street, between Eastern Main Road and Cunapo Southern Road.
14. Motorists are prohibited from entering— No entry
- (a) Short Street, except maxi-taxis and marked Sangre Grande Regional Corporation vehicles; and
- (b) Royal Castle Corner Road, except Public Transport Service Corporation buses.
15. Motorists proceeding east along Eastern Main Road shall turn Left-turn left at Railway Road, Guaico Junction from Monday to Friday from only 6.00 a.m. to 9.00 a.m. and from 2.00 p.m. to 6.00 p.m., except on public holidays.
16. Public Transport Service Corporation buses proceeding south on Right turn Royal Castle Road shall turn right at Eastern Main Road. only
17. Motorists proceeding— Major/minor
- (a) on Brierly Street at its intersection with Ramdass Street, road shall have the right of way; and
- (b) east on Railway Road and Brierly Street at its intersection with Picton Road, shall have the right of way.
18. Maxi-taxis plying the Toco and Mayaro routes shall ply on the Maxi-taxi southern side of Railway Road, facing west (south of the new stand Bus Terminal) as marked.
19. Taxis plying the— Taxi stand
- (a) Coalmine and Tamana routes shall ply on the southern side of Mary Street, between George Street and Cunapo Southern Road, as marked;

- (b) Biche and Plum Mitán routes shall ply on the eastern side of Cunapo Southern Road (reversing from Mary Street), between Andre Street and the Paint Shop, facing south, as marked;
- (c) Toco route shall ply on the area north of Royal Castle (west of the old Bus Terminal compound), as marked;
- (d) Sookram Village/Sangre Grande District Hospital route (Ojoe Road taxis) shall ply on Ojoe Road, north of River Road, as marked; and
- (e) Quash Trace route (Foster Road taxis) shall occupy Foster Road, north of River Road, as marked.

No plying for
hire

20. Maxi-taxis shall not ply for hire on Eastern Main Road and on Brierly Street, one hundred metres in either direction from the Maxi-taxi Hub.

PART VI

GENERAL

Offence and
penalty

21. A person who contravenes any of the provisions of these Regulations is liable on summary conviction for a first offence, to a fine of seven hundred and fifty dollars, and on any subsequent conviction, to a fine of one thousand dollars.

Removal and
impounding
of vehicles
unlawfully
parked

22. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
