NOTICE OF SUBMISSION FOR PUBLIC COMMENT ON AN ENVIRONMENTAL IMPACT ASSESSMENT REPORT SUBMITTED BY THE NATIONAL GAS COMPANY OF TRINIDAD AND TOBAGO (NGC)

Notice is hereby given that the National Gas Company of Trinidad and Tobago Limited (NGC) is desirous of executing a new project involving the establishment of a Natural Gas Delivery pipeline from the Angostura Gas Export Platform in Block 2C to the NGC Abyssinia Slug Catcher facility in Beachfield. This project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order, 2001, as amended by the Certificate of Environmental Clearance (Designated Activity) (Amendment) Order, 2007, thus requiring a Certificate of Environmental Clearance ("the Certificate") pursuant to section 35 of the Environmental Management Act, ("the Act").
