ORDER

Made by the Minister under section 46(6) of the National Insurance Act

THE NATIONAL INSURANCE (EMPLOYMENT INJURY) (PAYMENT OF MEDICAL EXPENSES) (AMENDMENT) ORDER, 2008

1. This Order may be cited as the National Insurance _{Citation} (Employment Injury) (Payment of Medical Expenses) (Amendment) Order, 2008.

2. In this Order, "the Order" means the National Insurance Interpreta-(Employment Injury) (Payment of Medical Expenses) Order.

3. The Order is amended by deleting clause 3 and substituting the Clause 3 amended following clause:

"Maximum 3. (1) The aggregate payment of medical expenses shall not exceed—

- (a) the sum of eighteen thousand dollars; and
- (b) the sum of twenty-two thousand, five hundred dollars, with effect from 7th January, 2008.

(2) A maximum of—

- (a) two examinations of Magnetic Resonance Imaging ("MRI") per injury shall be covered; and
- (b) two thousand dollars shall be payable for each MRI examination.".
