ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (POINT FORTIN BOROUGH DAY CELEBRATIONS) ORDER, 2008

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Point Fortin Borough Day Celebrations) Order, 2008.
- 2. This Order has effect between the hours of 6.00 p.m. on Friday Duration 2nd May, 2008 to 6.00 a.m. on Sunday 4th May, 2008.
 - 3. Vehicular traffic is prohibited on the following:

Vehicular traffic

- (a) Point Fortin Main Road, between Reid Road and prohibited Tanner Street;
- (b) Guapo-Cap-de-Ville Road, between Reid Road and Tank Farm Road;
- (c) Adventure Road:
- (d) Richardson Street, between Guapo-Cap-de-Ville Road and Canaan Road; and
- (e) Techier Main Road, between Kalloo Road and Adventure Street.
- 4. Parking is prohibited on the following:

Parking prohibited

- (a) Point Fortin Main Road from Dunlop Roundabout to Reid Road;
- (b) Techier Main Road from Point Fortin Road to Kalloo Street;
- (c) Canaan Road;
- (d) Richardson Street;
- (e) Volunteer Road;
- (f) Clifton Hill;
- (g) Guapo-Cap-de-Ville Road; and
- (h) Tank Farm Road.

Emergency routes

- 5. Drivers on an emergency shall proceed along one of the following routes:
 - (a) from Techier Road, turn left onto Canaan Road and right onto Volunteer Road; and
 - (b) from Guapo-Cap-de-Ville Road onto Tank Farm Road through Clifton Hill.

Taxi stands

- 6. Drivers of taxis shall operate as follows:
 - (a) San Fernando taxis shall operate from the western side of Reid Street, north of the Point Fortin Road; and
 - (b) Erin taxis shall operate from the intersection of Guapo-Cap-de-Ville Road and Reid Road, in the vicinity of the gas station.

Removal impounding of vehicles unlawfully parked 7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
