- (b) San Fernando, from 9.00 a.m. to 6.00 p.m. on Sunday 3rd February, 2008; and
- (c) Tunapuna, from 1.00 p.m. to 6.00 p.m. on Sunday 3rd February, 2008.

10. Vehicular traffic is prohibited on—
