A PROPOSED SETTLEMENT AGREEMENT

[Pursuant to Part VIII of Securities Industry (Hearings and Settlements) Practice Rules, 2008 ("the Rules")]

ORDER OF THE COMMISSION

WHEREAS Point Lisas Industrial Port Development Corporation Limited ("the Respondent") has contravened section 66(3) of the Securities Industry Act, 1995 ("the Act") by failing to file with the Commission and issue a press release authorized by a senior officer within seven days (7) from:

- (a) 14th August, 2009 when Mr. Roger Traboulay resigned as President;
- (b) 25th August, 2009 when Mr. Ernest Ashley Taylor was appointed as President (Acting);
- (c) 9th February, 2010 when Mr. Wayne Punnette was appointed as a Director;
- (d) 30th September, 2009 when Mr. Rikkhi Rampersad ceased to hold office as a Director; and
- (e) 1st March, 2010 when Mr. Ernest Ashley Taylor was appointed as President;

And Whereas by letter dated 24th August, 2010 the Commission advised the Respondent that it was in contravention of section 66(3) of the Act by failing to file with the Commission and issue a press release authorized by a senior officer within sevendays (7) from:

- (a) 14thAugust, 2009 when Mr. Roger Traboulay resigned as President;
- (b) 25th August, 2009 when Mr. Ernest Ashley Taylor was appointed as President (Acting);
- (c) 9th February, 2010 when Mr. Wayne Punnette was appointed as a Director;
- (d) 30th September, 2009 when Mr. Rikkhi Rampersad ceased to hold office as a Director; and
- (e) 1st March, 2010 when Mr. Ernest Ashley Taylor was appointed as President;

And Whereas on the 8th day of June, 2011 the Respondent entered into a proposed settlement agreement with the Staff of the Commission which was signed by the duly authorized representative of the Commission for and on behalf of the Commission and the duly authorized representative of the Respondent for and on behalf of the Respondent ("the Settlement Agreement"), in which the parties agreed to a settlement, subject to the approval of the Settlement Panel;

And Whereas the Settlement Panel approved the Settlement Agreement and agreed to submit the Settlement Agreement to the Commission;

And Whereas the Respondent shall pay to the Commission the sum of One Hundred Thousand Dollars (\$100,000.00) within twenty-eight days of the making of this Order;

And Whereas the Commission has considered the Settlement Agreement and is of the opinion that it is in the public interest to make this Order;

It is hereby ordered that:

- (a) The procedure outlined under the Securities Industry (Hearing and Settlements) Practice Rules, 2008 has been followed:
- (b) The Respondent has contravened section 66(3) of the Act and shall within twenty-eight (28) days of the making of this Order pay to the Commission the sum of One Hundred Thousand Dollars (\$100,000.00) as the fine in this matter; and
- (c) This Order shall be published in the Trinidad and Tobago Gazette, in the daily newspapers.

REQUEST FOR EXPRESSIONS OF INTEREST FOR CONSULTING SERVICES FOR THE DESIGN OF ELECTRONIC DOCUMENT MANAGEMENT SYSTEM FOR THE SERVICE COMMISSION DEPARTMENT, GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO—LOAN NO. LO 1808/OC—TT—CONTRACT/BID NO. 08

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) has received financing from the Inter-American Development Bank (IDB), and intends to apply part of the proceeds to payments under the project, Electronic Government and Knowledge Brokering Program for the Procurement of a Consulting Firm to assist with the Design of an Electronic Document Management System for the Service Commission Department. This process requires bidders to have specific experience and capabilities in the following four (4) related components:

- (1) Information Management Needs Assessment and Gap Analysis. In this component the consulting firm is expected to deliver an Information Management Needs Assessment Gap Analysis report which details the assessment and recommendations arising from the key activities;
- (2) Functional Requirements and Specifications for an Electronic System. In this component the Service Commission Department is seeking to implement a distributed, scalable, interoperable and adaptable computing environment which encourages the distribution of electronic documents;
- (3) Project Management Planning and Support. In this component the consulting firm is required to develop the overall plan of action (phased approach) for the implementation of a document mangement solution across the four Commissions of the Service Department inclusive of the retrospective back filling and conversion options. The consulting firm is also expected to engage key stakeholders and sponsors and develop a Project Management/Work Plan;
- (4) Preparation of Terms of Reference (TORs), Request for Proposals (RFPs) and technical support with tender evaluation. In this component the consulting firm is required to develop Terms of Reference (TORs) and Request for Proposals (RFPs) of services to be procured for the implementation of the project based on the documented requirements. The TORs and RFPs must meet procurement requirements as prescribed under the Inter-American Development Bank (IADB) procurement regulations.

In this regard, the Central Tenders Board Divison on behalf of the Ministry of Public Administration invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information establishing that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).

Consultants may associate with other personnel/firms to enhance their qualifications.

Consultants will be selected in accordance with the policies of the IDB detailed in the "Policies for Selection and Contracting of Consultants financed by the IDB" which can be found at the website: http://www.iadb.org/procurement
