ORDER OF THE COMMISSION

WHEREAS Caroni (1975) Limited ("the Respondent"):

- (a) Failed to file its audited Comparative Financial Statement on or before 28th September, 2009 for the year 2009;
- (b) Failed to file its Annual Report on or before 30th October, 2009 for the year 2009;
- (c) Filed a copy of its Amended Registration Statement past the due date of 8th July for the years 2005, 2006, 2007 and 2008;
- (d) Failed to file its Amended Registration Statement on or before 8th July, 2009 for the year 2009;
- (e) Failed to file its Interim Financial Statement on or before 1st March for the years 2005, 2006, 2007 and 2008;
- (f) Filed its Interim Financial Statement on 27th September, 2010, past the due date of 1st March, 2010 for the year 2010;
- (g) Failed to file its audited Comparative Financial Statement on or before 28th September for the years 2005 and 2010;
- (h) Filed a copy of its audited Comparative Financial Statement past the due date of 28th September for the years 2006, 2007 and 2008; and
- (i) Failed to file its Annual Report on or before 1st October for the years 2005, 2006, 2007 and 2008.

And Whereas by Notices of Contravention S.I. Nos. 28 to 29 of 2010 dated 28th April, 2010 and S.I. Nos. 72 to 78 dated 8th October, 2010 the Commission advised the Respondent that it was in contravention of sections 64(3), 66(1)(a) and 66(2) of the Securities Industry Act, 1995 ("the Act") and By-Laws 55(1) and 56(1) of the Securities Industry By-Laws, 1997 ("the By-Laws") by:

- (1) Failing to file its audited Comparative Financial Statement on or before 28th September, 2009 for the year 2009;
- (2) Failing to file its Annual Report on or before 30th October, 2009 for the year 2009;
- (3) Filing a copy of its Amended Registration Statement past the due date of 8th July for the years 2005, 2006, 2007 and 2008;
- (4) Failing to file its Amended Registration Statement on or before 8th July, 2009 for the year 2009;
- (5) Failing to file its Interim Financial Statement on or before 1st March for the years 2005, 2006, 2007 and 2008;
- (6) Filing its Interim Financial Statement on 27th September, 2010, past the due date of 1st March, 2010 for the year 2010;
- (7) Failing to file its audited Comparative Financial Statement on or before 28th September for the years 2005 and 2010;
- (8) Filing a copy of its audited Comparative Financial Statement past the due date of 28th September for the years 2006, 2007 and 2008; and
- (9) Failing to file its Annual Report on or before 1st October for the years 2005, 2006, 2007 and 2008.

And Whereas on the 8th day of September, 2011 the Respondent entered into a proposed settlement agreement with the Staff of the Commission which was signed by the duly authorized representative of the Commission and the duly authorized representative of the Respondent ("the Settlement Agreement"), in which the parties agreed to a settlement, subject to the approval of the Settlement Panel of the Commission ("Settlement Panel");

And Whereas the Settlement Panel approved the Settlement Agreement and agreed to submit the Settlement Agreement to the Commission;

And Whereas the Respondent has agreed to pay the sum of two hundred and fifty dollars (\$250.00) for each of the failures to file its:

- (i) Annual Report for the years 2006, 2007, 2008 and 2009, a total penalty of one thousand dollars (\$1,000.00);
- (ii) Audited Comparative Financial Statements for the years 2006, 2007, 2008, 2009 and 2010, a total penalty of one thousand, two hundred and fifty dollars (\$1,250.00);
- (iii) Interim Financial Statements for the years 2006, 2007, 2008 and 2009, a total penalty of one thousand dollars (\$1,000.00); and
