## TENDER FOR THE UPGRADING OF THE POINT FORTIN MARKET FOR THE MINISTRY OF LOCAL GOVERNMENT

TENDERS are invited for the upgrading of the Point Fortin Market for the Ministry of Local Government.

Tender documents can be obtained during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port-of-Spain.

Tenderers are required to pay a tender deposit of five hundred dollars (\$500.00) payable by cash or certified cheque to the Director of Contracts, Central Tenders Board, 116, Frederick Street, Port-of-Spain. This deposit will be received from Monday to Friday between the hours of 9.00 a.m. to 12.00 noon and 1.00 p.m. to 3.00 p.m. The original receipt must be attached to the tender.

A pre-tender meeting followed by a site visit will be held for prospective tenderers at 10.30 a.m. on Friday 3rd June, 2011 at the Point Fortin Market, Guapo-Cap-de-Ville Main Road, Point Fortin.

Tenders must be accompanied by-

- (a) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing of the tender;
- (b) valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original tender document and one (1) copy of the Form of Tender and Bills of Quantities must be placed in a sealed envelope, addressed to the Chairman, Central Tenders Board, 116, Frederick Street, Port-of-Spain and clearly marked on the outside: "Tender for the upgrading of the Point Fortin Market for the Ministry of Local Government".

The envelope must be deposited in the Brown Tenders Box located in the lobby of the Board's Office not later than 1.00 p.m. on Thursday 16th June, 2011.
