PREQUALIFICATION OF CONTRACTORS FOR AGRICULTURAL ACCESS ROADS AND WATER MANAGEMENT INFRASTRUCTURE PROJECTS FOR THE ENGINEERING DIVISION, MINISTRY OF FOOD PRODUCTION

THE Ministry of Food Production is desirous of prequalifying Contractors for Rehabilitation and Maintenance of Agricultural Access Roads and Water Management Infrastructure Projects for a period of two (2) years as follows:

1. Rehabilitation of Agricultural Access Roads
2. Periodic Maintenance of Agricultural Access Roads
3. Water Management Infrastructure Projects

Applicants are expected to have the practical skill and experience acquired as a contractor in the execution of works of a similar nature and to be equipped with an ample quantity of manpower, suitable plant and equipment, financial capacity and in every respect, fully competent to undertake the execution of the contracts.

- (b) a valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original and one (1) copy of the completed prequalification applications for each project must be placed in separate sealed envelopes and addressed to the Chairman, Central Tenders Board, 116, Frederick Street, Port-of-Spain and clearly marked on the outside—"Prequalification of Contractors for Agricultural Access Roads—Rehabilitation for the Engineering Division, Ministry of Food Production" or "Prequalification of Contractors for Agricultural Access Roads—Maintenance for the Engineering Division, Ministry of Food Production" or "Prequalification of Contractors for Water Management Infrastructure Projects for the Engineering Division, Ministry of Food Production".

Envelopes must be deposited in the Brown Tenders Box located in the lobby of the Board's Office not later than 1.00 p.m. on Thursday 15th November, 2012.
