CONDITIONS OF SALE:

- Eighteen vehicles conform to the Ministry of Trade and Industry guidelines. Approval is granted for the sale of these vehicles <u>to be registered for the roads of Trinidad</u> <u>and Tobago.</u>
- (2) Twelve vehicles did not meet the requirements and approval will be granted for sale by auction to be scrapped for spare parts only. Within seven (7) days upon receipt of the vehicle, certification of its scrapping for parts will be confirmed on the site by an officer of the Licensing Authority of the Ministry Transport.
- (3) All Vehicular Lots will require a licence from the Ministry of Trade and Industry (Licensing Unit TTMA Building, tenth avenve Barataria) for removal.
- (4) All lots will be sold subject to an upset price which will be announced on the day of the sale.
- (5) The owner of vehicle/s have until 4:00 pm on the day prior to the sale, to pay the outstanding store rent in order to have any vehicle removed from the sale.
- (6) All lots will be sold on an "as is" "where is" basis.

 - (a) The purchase price payable to the Port Authority.

 - (c) Any taxes or duties chargeable under any law other than duty imposed under the Customs Act calculated by reference to the purchase price.
